An Ordinance to amend the Dock Regulations on Birch Lake Ordinance (Part 55 of the compiled ordinances of Porter Township, as amended) to provide the Cass County Parks and Recreation Department retain governance of Lake Park; to provide for an effective date; and to repeal any parts of the Dock Regulations on Birch Lake Ordinance in conflict herewith.

**SECTION 1**

**AMENDMENT TO SECTION 111.315(h) DOCK REGULATIONS OF THE**  
**PORTER TOWNSHIP DOCK REGULATIONS OF BIRCH LAKE**  
**ORDINANCE**

Part 55 of the compiled ordinances of Porter Township, Section 111.315 subsection h of the Porter Township Dock Regulations on Birch Lake Ordinance is hereby amended by addition of item 3, and shall read in its entirety:

“3) The Cass County Parks and Recreation Department retains their authority to govern the usage of the small parcel of land commonly known as Lake Park.”

The remainder of Part 55, Section 111.315(h) and its subsections is hereby retained intact.

**SECTION 2**

**SEVERABILITY CLAUSE**

Should any provision or part of the within ordinance be declared by any court of competent jurisdiction to be invalid or unenforceable, the same shall not affect the enforceability of the balance of this Ordinance which shall remain in full force and effect.

**SECTION 3**

**SAVINGS CLAUSE**

Legal proceedings presently pending on an Ordinance provision which is hereby repealed or under a provision of the Porter Township Dock Regulations on Birch Lake Ordinance that was renumbered by this Ordinance may proceed to judgment or decision and shall not be affected by this Ordinance.

**SECTION 4**

**REPEAL OF CONFLICTING ORDINANCE PROVISIONS**

All Ordinance provisions in conflict herewith are hereby repealed.

**SECTION 5**

**EFFECTIVE DATE**

The effective date of this amendatory ordinance shall be 30 days following a publication of a summary thereof after adoption by the Porter Township Board.
