REPORTS

IA's Monthly Report-Rob Smith

- Rob stated that the Sewer Plant continues to run in excellent condition.
- Rob stated that disconnect/reconnect inspections performed by his staff are not part of the contract with IA and if they continue, IA will have to charge for them. Rob stated that one of the Township inspectors should do disconnect/reconnect inspections since they are trained to do so and his staff isn't. Carl will bring this up at the Township meeting.
- Rob stated that his promotion has not occurred yet.
- Dave stated that, after reviewing the IA contract, there is not a specific provision requiring IA to have a certain type of licensed person on site to satisfy the contract.
