## IA's Monthly Report-Jon Petrasek

- Jon stated that the plant is running well.
- Jon reviewed the IA report for September 2023.
- The belt press is not running as of 10/3/2023. Jon said that Sierra Brown put a pause on it running. At the 9/5/2023 Sewer Board meeting Jon stated that it would be running on 9/7/2023. Jon will find out why it was put on a pause.
- There were 5 emergency callouts during September 2023.
- Jon stated that the PLC system is outdated. During September when it went down, the plant had to be run manually for 12 hours. A replacement PLC system would cost \$80K.

# Financial Review-John Penkala

John Penkala stated that the total past due at 9/30/23 was \$74,378 which includes \$25,077 in annual Sewer Assessments. \$6k in penalties were added to the past due Sewer Assessments. The loan from the Township to the Sewer was \$115,719 at 9/30/23.
